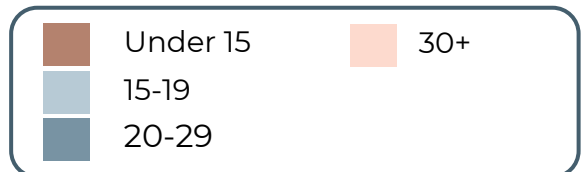
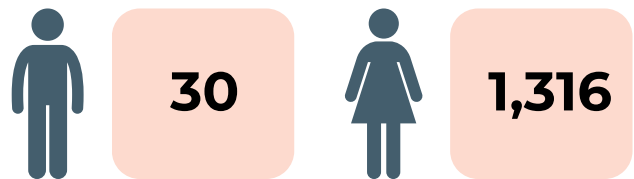
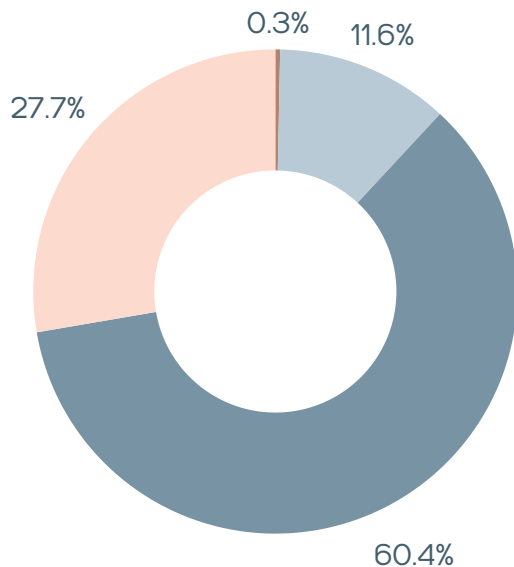
# 2024 IMPACT REPORT
